RESOLUTION 2012-06 2012 BOARD OF DIRECTORS ELECTION

Whereas, on June 30, 2007, the Eastern Sandoval County Arroyo Flood Control Authority ("ESCAFCA"), was duly organized by statute by the New Mexico State Legislature; on June 12, 2007, the appointed Board of Directors met; and on November 4, 2008, its Officers and Directors were duly elected and qualified; and

Whereas, the terms of Director Jack Torres and Director Wayne Sandoval expire on December 31, 2012; and an election for both Directors shall be held at the November, 2012 general election; and

Whereas, it is necessary for the Board of Directors of ESCAFCA to call an election to be held concurrently with the General Election on the 6th day of November 2012, for the purpose of electing two Directors. The Director from District One [Sandoval County Precinct 1] shall serve a six year term beginning January 1, 2013, and ending December 31, 2018. The Director from District Three [Sandoval County Precincts 2 and 3] shall serve a four year term beginning January 1, 2013 and ending December 31, 2016.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE EASTERN SANDOVAL COUNTY ARROYO FLOOD CONTROL AUTHORITY:

SECTION 1. That an election of the qualified voters of the Eastern Sandoval County Arroyo Flood Control Authority shall be held for and within ESCAFCA concurrently with the General Election on Tuesday, November 6, 2012, between the hours of 7:00 a.m. and 7:00 p.m. of said date. The qualified electors of ESCAFCA shall elect two [2] qualified Directors, as hereinafter provided, who shall take office on January 1, 2013. The Director from ESCAFCA District One [Sandoval County Precinct 1] shall serve a six year term ending December 31, 2018. The Director from ESCAFCA District Three [Sandoval County Precincts 2 and 3] shall serve a four year term ending on December 31, 2016.

SECTION 2. That electronic or automatic voting machines or paper ballots shall be used in said election. The official ballot shall designate the candidates for Director and shall instruct the voters, in both English and Spanish, as to the methods of voting for the director.

SECTION 3. That at the election, the qualified electors of ESCAFCA shall elect respectively, two [2] qualified Directors of ESCAFCA who shall take office on January 1, 2013. The Director from ESCAFCA District One [Sandoval County Precinct 1] shall serve a six year term ending December 31, 2018. The Director from ESCFCA District Three [Sandoval County Precincts 2 and 3] shall serve a four year term ending December 31, 2016. The candidates receiving the highest number of votes in each ESCAFCA District shall be elected as Directors. Nominations for the Board of Directors may be made in writing by petition of no less than fifty qualified electors, designating the name of the person nominated, reciting that the subscribers thereto are qualified electors from the respective ESCAFCA District, and that the candidate designated therein is a qualified elector from within the respective ESCAFCA District. Forms for nomination shall be in the form shown as Attachment One (1) to this Resolution, entitled "Nominating Petition." Each written nomination may designate only one qualified elector as a candidate. No qualified elector may nominate more than one candidate. Nominations shall be submitted to the ESCAFCA Office, located on the second floor of the Town Hall of the Town of Bernalillo, 829 Camino del Pueblo, Bernalillo, New Mexico, by 5:00 p.m. Tuesday, June 26, 2012. Signatures on the petitions will be assumed to be valid, and will not be validated by ESCAFCA. If validity of signatures is challenged, the matter shall be referred to the County Clerk. If a candidate does not withdraw his/her name before September 4, 2012, his/her name shall be placed on the ballot.

SECTION 4. That positioning on the ballot shall be by draw, by the candidates or their designee (with authorizing letter) at the ESCAFCA Office on June 26, 2012 at 5:15 p.m.

SECTION 5. That the provisions of this Resolution are subject to the laws of the State of New Mexico.

SECTION 6. That no person shall be permitted to vote at the election unless he/she is a qualified elector from within the designated boundaries of each respective ESCAFCA District, and is a registered voter as determined by the County Clerk of Sandoval County. The term "qualified elector" means a person qualified to vote in General Elections in the State of New Mexico, who is a resident of the respective ESCAFCA District.

SECTION 7. That the election precincts and divisions for the election of directors are those which will be established by the County Commission of Sandoval County for the General Election, with such amendments thereto as may be thereafter made by the County Commission from time to time prior to the election.

SECTION 8. That each and every judge and clerk in precincts located in ESCAFCA Districts appointed by the County Commission of Sandoval County is hereby designated, and shall also serve, as judge, and clerk, respectively, of the election held pursuant to this Resolution.

SECTION 9. That the Secretary of ESCAFCA shall provide or cause to be provided at each polling place such instructions, sample ballots, electors' affidavits, and other materials and supplies required for the election.

SECTION 10. That the election shall be conducted in the same manner as provided by the laws of the State of New Mexico for the conduct of General Elections, except as provided to the contrary in this Resolution and Section 72-16-1 *et seq.*, N.M.S.A. 1978, as amended.

SECTION 11. For the purposes of determining the qualifications of any person desiring to vote as a qualified elector of ESCAFCA, any judge of election may require the execution by such person of an affidavit to evidence such qualifications. Such affidavits shall be prima facie evidence of the facts stated therein and shall be substantially in the form shown as Attachment Two (2) to this Resolution, entitled "Elector's Affidavit for Election of Directors".

SECTION 12. That immediately after the closing of the polls, the results shall be certified and the returns therefore shall be made and canvassed at the time and in the manner provided by law. The canvassing

body shall certify promptly and transmit to the Secretary of ESCAFCA a statement of the results of the vote upon all candidates.

SECTION 13. That the Secretary of ESCAFCA shall cause notice of calling the election and calling for nominations for director to be published forthwith at least once a week for three (3) consecutive weeks, the last publication to be given on or before June 12, 2012 in the following newspapers:

- a) The Albuquerque Journal published in the City of Albuquerque, New Mexico,
- b) El Seminario Newspaper, published in Albuquerque, New Mexico, which newspapers are of general circulation within the boundaries of ESCAFCA. The form of such notice shall be in substantially the form shown in Attachment Three (3) to this Resolution and entitled "Notice of Call of Election and of Nomination of Directors of the Eastern Sandoval County Arroyo Flood Control Authority".

SECTION 14. That the Secretary of ESCAFCA shall cause notice of the election to be published at least once a week for three consecutive weeks, the last publication to be given on or before October 30, 2012, in the following newspapers:

- a) The Albuquerque Journal published in the City of Albuquerque, New Mexico,
- b) El Seminario Newspaper, published in Albuquerque, New Mexico, which newspapers are of general circulation within the boundaries of ESCAFCA. The notice of election shall be substantially in the form shown in Attachment Four (4) to this Resolution and entitled "Notice of Election of Directors of the Eastern Sandoval County Arroyo Flood Control Authority".

SECTION 15. That the officers of ESCAFCA be, and they hereby are, authorized to take all action necessary to effectuate the provisions of this Resolution, including, without limiting the generality of the foregoing, the printing of instructions, the furnishing of supplies, the publication of notices, and payment for costs directly related to the election of ESCAFCA directors.

SECTION 16. That if any section, paragraph, clause, or provision of this Resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of the Resolution.

SECTION 17. That this Resolution shall be in full force and effect after its passage and adoption.
